

Mail-In Rebate Claim Form

Rebate valid for dates of purchase: 05/12/2009 to 05/25/2009

Please go to <http://www.mir411.com/registerrebate/> to register your rebate. A Claim ID will be provided which must be submitted on the front of the envelope. You must register online before the claim is mailed in.
